

ORDINANCE NO. 2017-11

**AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE BOROUGH OF ELMER,
SALEM COUNTY, STATE OF NEW JERSEY, AUTHORIZING THE UNDERTAKING
OF THE RECONSTRUCTION OF UNION STREET AND HITCHNER AVENUE,
APPROPRIATING THEREFORE THE SUM OF \$147,000.00 AND PROVIDING THAT
SUCH SUM SO APPROPRIATED SHALL BE RAISED FROM A NEW JERSEY
DEPARTMENT OF TRANSPORTATION GRANT AND FROM THE BOROUGH'S
CAPITAL IMPROVEMENT FUND**

BE IT ORDAINED, by the Mayor and Council of the Borough of Elmer, County of Salem and State of New Jersey, as follows:

Section 1.

The Borough of Elmer, County of Salem, State of New Jersey (the "Borough") is hereby authorized to undertake the reconstruction of Union Street and Hitchner Avenue. Said road improvements shall include all work, materials and appurtenances necessary and suitable therefor.

Section 2.

The sum of \$147,000.00 is hereby appropriated to the payment of the cost of the improvements authorized and described in Section 1 hereof (hereinafter referred to as "purpose"). Said appropriations shall be raised from a New Jersey Department of Transportation ("NJDOT") grant and from the Borough's Capital Improvement Fund, as hereinafter provided. The sum of \$123,632.00 received or to be received from the NJDOT is hereby appropriated to the payment of the cost of said purpose. The sum of \$23,368.00 is hereby appropriated from the Borough's Capital Improvement Fund to the payment of the cost of said purpose.

Section 3.

Said improvements are lawful capital improvements of the Borough having a period of usefulness of at least five (5) years. Said improvements shall be made as general improvements, no part of the cost of which shall be assessed against property specially benefited.

Section 4.

The capital budget is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Borough Clerk and is available for public inspection.

Section 5.

The sum of \$147,000.00 is hereby appropriated for the aforementioned purpose.
