#### ORDINANCE NO. 2018-6

## AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE BOROUGH OF ELMER, SALEM COUNTY, STATE OF NEW JERSEY, AMENDING CHAPTER 14 ENTITLED "WATER" OF THE CODE OF THE BOROUGH OF ELMER

**WHEREAS,** the Mayor and Council of the Borough of Elmer have determined that certain amendments to Chapter 14 entitled "Water" are necessary; and

**WHEREAS,** in all other respects Chapter 14 entitled "Water" shall remain in full force and effect;

**NOW, THEREFORE, BE IT ORDAINED,** by the Mayor and Council of the Borough of Elmer, County of Salem and State of New Jersey, and it is hereby enacted and ordained by the authority of same as follows:

### Section 1.

Section 14-1.21(a) entitled "Waiver of Water Service Fees and Charges" shall be amended as follows:

a. The Mayor and the Borough Council hereby waives any and all charges, be it fees for connection, maintenance, consumption, or otherwise, relating to the Elmer water supply and Elmer Water Department for the following entities and/or properties:

- 1. Borough Hall of the Borough of Elmer;
- 2. Borough of Elmer Fire Department;
- 3. Veterans Monument property;
- 4. Little League Park (limited to the park's restrooms and club house);
- 5. Elmer Elementary School;
- 6.5. Elmer Ambulance Corps; and,
- 7.6. Mini park at State and Main Streets.

#### Section 2.

#### Repealer.

All prior Ordinances or parts of Ordinances inconsistent with this Ordinance be and the same are hereby repealed to the extent of such inconsistencies.

# Section 3.

### Severability.

Should any section, clause, sentence, phrase or provision of this Ordinance be declared unconstitutional or invalid by a Court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

### Section 4.

#### When effective.

This Ordinance shall take effect immediately upon final passage and publication in accordance with law.
