# ORDINANCE NO. 2018-12

# AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE BOROUGH OF ELMER, SALEM COUNTY, STATE OF NEW JERSEY, AMENDING CHAPTER 14 ENTITLED "WATER" OF THE CODE OF THE BOROUGH OF ELMER

WHEREAS, the Mayor and Council of the Borough of Elmer have determined that certain amendments to Chapter 14 entitled "Water" are necessary; and

WHEREAS, in all other respects Chapter 14 entitled "Water" shall remain in full force and effect;

## Section 1.

§14-1.3 entitled "Advanced Quarterly Service Charges", subsection (a), shall be amended as follows:
