### ORDINANCE NO. 2020-8

# AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE BOROUGH OF ELMER, SALEM COUNTY, STATE OF NEW JERSEY, AMENDING CHAPTER 11-5 ENTITLED "LANDLORD REGISTRATION" OF THE CODE OF THE BOROUGH OF ELMER

**WHEREAS**, the Mayor and Council of the Borough of Elmer have determined that certain amendments to Chapter 11-5 entitled "Landlord Registration" are necessary; and

**WHEREAS,** in all other respects Chapter 11-5 entitled "Landlord Registration" shall remain in full force and effect;

**NOW, THEREFORE, BE IT ORDAINED,** by the Mayor and Council of the Borough of Elmer, County of Salem and State of New Jersey, and it is hereby enacted and ordained by the authority of same as follows:

## Section 1.

Chapter 11-5 entitled "Landlord Registration", at §11-5.5 entitled "Requirements for Registration" shall be amended as follows:

§11-5.5 Requirements for Registration.

b. Every person required to file a registration certificate pursuant to this section shall file an amended registration certificate within twenty (20) days after any change in the information required to be included thereon. No fee shall be required for the filing of <u>a an</u> <u>amendment to the</u> registration certificate <del>or amendment thereof</del>. However, an amendment for the sole reason that tenancy in a rental unit has changed shall not be applicable to rental units that are motels, hotels, bed and breakfasts or rooming or boarding houses:

#### Section 2.

#### Repealer.

All prior Ordinances or parts of Ordinances inconsistent with this Ordinance be and the same are hereby repealed to the extent of such inconsistencies.

#### Section 3.

#### Severability.

Should any section, clause, sentence, phrase or provision of this Ordinance be declared unconstitutional or invalid by a Court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

Section 4.

### When effective.

This Ordinance shall take effect immediately upon final passage and publication in accordance with law.
