### **MAYOR'S ALERT**

**BOROUGH HALL CONSTRUCTION** – The Borough of Elmer received a NJ Department of Community Affairs Small Cities Grant that will pay for 85% of the construction cost to make improvements to the Borough Hall to comply with the American with Disabilities Act (ADA). Construction at the Borough Hall should be occurring by fall 2021 involving both interior and exterior renovations. The library ramp and sidewalks will be replaced and a new parking lot area will be paved, so access to the building may be impacted during construction.

**FERAL/WILD CATS** – There are areas in the Borough that have had numerous animal control complaints about colonies of feral/wild cats. Please be aware that **if you feed cats outdoors on your property** you are acknowledging 'ownership' and **you must vaccinate and license them** per Borough Code Chapter 5. Feral cats are very self-sufficient and do not need to be fed, and feeding them is contributing to the population explosion in these areas. Council Member James Zee is interested in planning a trap, spay/neuter/vaccinate, and release program and is looking for volunteers. Please contact him at (609) 774-8628 if you truly want to humanely help reduce the feral/wild cats in our community.

**TRICK OR TREAT HOURS** – Halloween Trick or Treat Hours are currently scheduled for **Saturday**, **October 30**, **2021 from 5:00 PM - 8:00 PM**. There is an 8:00 PM curfew for Friday (October 29) and Saturday (October 30) for anyone under the age of 17 unless accompanied by an adult. **ELECTIONS** – The polling location for registered voters in the Borough of Elmer is the **ELMER FIRE HALL**, **110 Penn St**. in the meeting room in the back of the building. The deadline to register to vote in the next general election is **October 12**, **2021** (21 days prior to the election). FREE RABIES CLINIC FOR CATS AND DOGS – The State of NJ requires that all rabies shots be good through November 1 of the license year. This year's FREE Rabies Clinic is scheduled for Saturday, November 6, 2021, 10:00 AM - 11:00 AM at the Elmer Fire Hall, 110 Penn St. NO LICENSES WILL BE ISSUED AT THIS TIME. If your pet's

rabies shot expires prior to November 1, 2022, you will need to get a new rabies shot to qualify for a 2022 pet license.

**DOG & CAT LICENSES** – Dog & cat licensing begins **January 1, 2022** and the deadline to send in your 2022 license payment is **March 31, 2022**. There is a **\$20 per pet** late fee and possible additional court fines if you pay after **March 31, 2022**. State statute requires all pets be vaccinated before 2022 licenses are issued and rabies must be good through **November 1, 2022**. License fees are \$10 for spayed/neutered dog/cat, \$15 for non-spayed/unneutered dog/cat. License payments may be mailed to the Animal Registrar, Elmer Borough, PO Box 882, Elmer NJ 08318, or dropped in the drop box to the right of the glass doors on the south side entrance of the building. RECYCLING NEWS – PLEASE HELP US WIN THE BATTLE AGAINST CONTAMINATION TO SAVE TAXPAYER MONEY! Our recyclers have become very strict on what can be recycled so when contamination occurs the entire truck may be sent to the landfill causing additional costs to Borough taxpayers. In addition to glass, cans, paper &

cardboard, **ONLY** bottle-grade plastic labeled 1 and 2 are now accepted, and **NO PLASTIC LIDS** are permitted; plastic lids now go in the trash. **NEVER use plastic bags** for recycling, and please rinse all containers. **Recycling Restrictions**:

STORMWATER POLLUTION AND WHAT WE CAN DO ABOUT IT — Water from rain and melting snow that flows over lawns, parking lots and streets is known as stormwater runoff. This water, which travels along gutters, into catch basins and through storm drain pipes and ditches, usually is not treated, but then flows or is discharged into local water bodies. Along the way, the stormwater picks up trash (fast-food wrappers, cigarette butts, Styrofoam cups, etc.) and toxins and other pollutants (gas, motor oil, antifreeze, fertilizers, pesticides and pet droppings). This polluted storm water can kill fish and other wildlife, destroy wildlife habitat, contaminate drinking water sources and force the closing of beaches because of health threats to swimmers. Human activity is largely responsible for the stormwater pollution. Everything that we put on the ground or into the storm drain can end up in our water. Each of us has a responsibility to make sure these contaminants stay out of our water.
