RESOLUTION FOR THE OFFICE OF THE TAX AND WATER COLLECTOR FOR THE YEAR <u>2014</u>

WHEREAS, the Borough of Elmer is able to set policies and procedures for the office of the Tax and Water Collector that allows for the best fiscal interest of the municipality,

NOW, THEREFORE, BE IT RESOLVED, that the Tax Collector, is hereby authorized and directed to the following:

TAXES

- 1. Interest on taxes shall be 8% on the first \$1,500 of the delinquency and 18% on all subsequent delinquency until the account is paid in full. All accounts have a 10 day grace period during each quarter when taxes are due.
- 2. A year end penalty of 6% for taxpayers with a delinquency in excess of \$10,000 who fail to pay the delinquency before the end of the year.
- 3. A tax sale of all delinquent accounts for the 2013 Municipal Taxes will be held no later than January 31, 2014.
- 4. A tax sale of all delinquent accounts for the 2014 Municipal Taxes will be held no later than January 31, 2015.
- 5. Delinquent tax accounts in the amount of +/- \$5.00 may, at the discretion of the tax collector be canceled prior to the tax sale.
- 6. Charges for Certificates of Redemption shall be \$25.00 per certificate.
- 7. Charges for Replacements of Loss Tax Sale Certificates shall be \$100.00
- 8. All Tax Sale Liens shall be redeemed through certified funds only (cash, money order, or certified check).
- 9. All payments made to clear accounts for tax sale must be made through certified funds only (cash, money order, or certified check).
- 10. Borough Charges for property clean-up, trash removal, and other similar charges shall be charged an interest rate of 18%, 30 days after the billing date.

WATER

- 1. A late fee penalty on water shall be 5% on the 11th day following the due date on the bill. All accounts have a 10-day grace period during each quarter when the bills are due.
- 2. A tax sale of all delinquent accounts for the 2013 Municipal Taxes will be held no later than January 31, 2014.

- 3. A tax sale of all delinquent accounts for the 2014 Municipal Taxes will be held no later than January 31, 2015.
- 4. All payments made to clear accounts for tax sale must be made through certified funds only (cash, money order, or certified check).
- 5. Delinquent water accounts in the amount of +/-\$5.00 may, at the discretion of the tax collector be canceled prior to the tax sale.

After remarks from Borough Council Members, Chief Financial Officer, Borough Clerk, and the Public, Mayor Stemberger read the following address.

MAYOR'S ADDRESS

As we begin our New Year, hear these words from the book of Deuteronomy, chapter 11:11-12: "But the land... is a land...which the Lord thy God careth for: the eyes of the Lord thy God are always upon it, from the beginning of the year even unto the end of the year". In this year's mayoral address, I am not going to speak about taxes, accomplishments, or problems in our town. Instead, I will talk about the community we love, the Borough of Elmer, NJ.

L.B. Cowman, author of the classic devotional"Streams in the Desert", penned these words for the New Year:"Today, dear friends, we stand upon the verge of the unknown. There lies before us the new year and we are going forth to possess it. Who can tell what we shall find? What new experiences, what changes shall come, what needs shall arise? But here is the gladdening message from our Heavenly Father, "Thy Lord thy God careth for it. His eyes are upon it away to the ending of the year."

She is certainly correct in saying who can tell. No one knows the future regardless what those fortune teller booths on the boardwalk try to tell - or should I say sell - you. But the great blessing of living in a small town is knowing that whatever the future holds you won't be alone. There is a caring community behind you.

Yesterday we mourned together at the funeral of one of our town's beloved citizens, Ethel Dodge. Many testified not only to her faith and perservence, but to times spent with her and the family in Dodge's market. It was great to hear the memories, but also to know that Ethel and her family knew she could call on members of the community to take her to the appointments, to visit her in times of need, to care for her. Early last year, the McDonald family suffered the tragic loss of their son, Lucas. What did his mother, Jeanette say to me? "This town is amazing". The support and caring they received and continue to receive has overwhelmed them.

And, that is what life in a small town is - a caring community. Look around you and notice the acts of kindness. See high school student Sandy Ludwig shoveling her elderly neighbor's walk after a snowstorm. Watch as walkers and runners toss their neighbors' papers onto their porch. Look at those picking up litter and keeping Elmer clean. On Thursday, you can see soup being delivered to shut ins. We have the Salvation Army and the free Clothes Closet operating out of the Presbyterian Church as well as Peter's Pantry Food Bank in the Methodist Church. Christmas was brighter for families due to these ministries operating within our town. And, so many others do their good deeds in secret - visiting our elderly, helping them with chores, offering financial assistance, being there for them.

As we begin another year together, I encourage you to see the blessings in this small town. Yes, we have our problems, especially in this struggling economy. Unfortunately, we have lost important businesses, but look at what we do have. Notice the new Dodge's still being a mainstay on the corner - a gathering place for locals as well as those passing through. A business continues at that corner and has for more than a hundred years. Did you know the Elmer Diner now donates soup to the soup ministry of the Elmer UMC? Do you see how the Bistro supports various causes through their special community outreach events? The Elmer IGA being a staunch supporter of our food bank, giving back to the community? This year they also made a huge contribution to Carla's kids - gifts for the homeless children in our county. There is Maninno's Pizza helping out the Hangar, the community youth center. We have several banks that do a great job of supporting our town. Pennsville Bank not only supported Ranch Hope this Christmas, but also donated to a needy family in town.
